

2019 Cork & Pork “Hot Wings” Application, Contest Rules, & Waiver

The “Hot Wings” Contest is free to enter. One single prize of \$50 will be paid to contest winner as determined by the rules and verified by the judge’s final decision. You should arrive 15 minutes prior to start time posted for the event. The contest begins promptly at 6:45 PM on the 21st of June on the Mid-City Mall parking lot in the stage area. This “Hot Wing” eating competition is open to all amateur eaters eighteen (18) years or older who are in good health and without a serious health problem. Eaters between the ages of sixteen to eighteen (16-18) can participate with a parent or guardian signature of consent.

Rules:

1. Each contestant will be provided 10 “Hot Wings” to eat in the shortest time possible.
2. Contestants are to remain seated while eating, no use of napkins or dipping sauces are allowed.
3. Competitors may not make physical contact with any other competitor at any time.
4. If a competitor regurgitates outside of their mouth at any time during the competition, he or she will be disqualified.
5. Chicken meat must be eaten directly from the bones. Stripping the bones of meat first and eating the meat at one time will not be allowed.
6. These on-the-bone wings must be completely eaten – only the cartilage on each end of the *drumettes* can remain on the bone. ALL meat must to be eaten clean from the bone. PLEASE DO NOT EAT THE BONES ☺
7. Competitors must place each and every finished chicken wing bone back in wing receptacle tray.
8. Once all wings have been properly eaten and swallowed, the contestant is to immediately stand, raise both arms and open mouth.
9. If contingencies or disputes arise before, during or after, the contest that is not explicitly covered by these official rules, the Executive Judge’s decision will stand with the same finality as the rules.

ACKNOWLEDGEMENT OF RISKS AND WAIVER OF LIABILITY:

Contestant acknowledges that there are risks of personal injury, illness and possible loss of life, and risks of damage to or loss of personal property, which may result from participating in this contest. Contestant voluntarily enters the Olde Town Covington “Hot Wing” Competition and assumes all of these risks. Contestant, as a condition of entry, agrees to indemnify, defend and hold harmless Olde Town Covington and co-sponsoring companies and their affiliates and agencies, and all officers, directors, employees, volunteers, and agents of the aforesaid entities, from any and all claims and costs, including attorneys’ fees, relating to, arising from or in connection with participation in this contest or the receipt or use of any prize. In so doing, contestant releases and indemnifies the aforesaid entities and individuals from liability for injuries or damages of any kind arising from or in connection with participation in this contest or the receipt or use of any prize. In no event shall Olde Town Covington be liable to a contestant for acts or omissions arising out of or related to the Contest or that contestant’s participation in the contest.
